Evergreen High School is an independent study school serving grades 9-12 in Eastern Madera County. It is a part of the Yosemite Unified School District and is located adjacent to Yosemite High School in Oakhurst. Evergreen has one classroom. There is a kitchen, restroom, and a nursery for the students' babies. The students have access to computers in the classroom and use them on a regular basis to complete their assignments. There are also laptop computers available for the students to check out to take home. The computers are connected to the Internet. Students transfer to Evergreen High School from Yosemite High School for a variety of personal reasons; some remain at EHS and graduate from there; others return to YHS to complete their schooling. Students spend a portion of one day a week at the school; the rest of their work is done at home. They are able to call the teachers on an as-needed basis and they can also communicate with them via e-mail. The district board of trustees approved college prep classes for Evergreen in August, 2007. The school was awarded a six year accreditation by the Western Association of Schools and Colleges (WASC), with a three year review, in 2008.

There is a play area at the school for the children of the students. The equipment was donated by a local resident. Community volunteers care for the young children while their mother or father is at school.

### III. School Climate

#### School Safety Plan (School Year 2007-08)

This section provides information about the school's comprehensive safety plan.

A major effort was made during the early part of 2007 to revise and update the district's safety plan and crisis response plan. The district hosted a School Safety Summit in February 2007 for all of the school districts in the area and all of the emergency services agencies. Using information gathered from the summit, and from meetings with emergency services agencies, the plan was updated to conform to the National Incident Management System (NIMS) as required by law. In the past, the crisis response plan had conformed to the Standardized Emergency Management System (SEMS), which was replaced by NIMS. In addition to the district crisis response plan, each school has its own Safe School Plan based on staff and student surveys. These plans were updated during the spring of 2008.

Evergreen High School maintains a safe and positive learning environment. Students are on the campus one day a week with varied schedules. Because of the limited amount of time each student spends at the site, there is not a lot of opportunity for interaction. The climate for learning is very positive. Students work one-on-one with their teacher and they receive a lot of encouragement and positive reinforcement. The students are very focused and self motivated.

##### School Safety Plan

Key elements of the School Safety Plan include:

- A. Personal Characteristics of Students and Staff
  - 1. Goal: To increase parental involvement.
  - 2. Activities: Staff and administration will make an extra effort to involve parents in the school and their student's education. They invited parents to be on the accreditation committee and to participate on the Senior Project boards.
- B. School's Physical Environment
  - 1. Goal: To increase the safety of the campus.

Activities: Have hand-held radios at the site so staff can contact the district office in an emergency and so they can be easily notified in an efficient manner if there is a problem at the adjacent schools.

The director of maintenance, operations and transportation is a member of the district management team and is in daily contact with the operations facilitator and the custodial supervisor to ensure an efficient cleaning process and schedule. The staff works together to ensure a clean and safe school.

**Deferred Maintenance Budget:**

The district participates in the State School Deferred Maintenance Program which provides state matching funds to assist school districts with expenditures for major repair or replacement of existing school building components. Deferred maintenance projects in the district include floor covering, heating and air conditioning, painting and paving.
