They are able to call the teachers on an as-needed basis and they can also communicate with them via e-mail. The district board of trustees approved college prep classes for Evergreen in August, 2007. The school was awarded a six year accreditation by the Western Association of Schools and Colleges (WASC), with a three year review, in 2008.

There is a play area at the school for the children of the students. The equipment was donated by a local resident. Community volunteers care for the young children while their mother or father is at school.

#### School Safety Plan (School Year 2008-09)

Yosemite Unified School District, and Evergreen High School, work with area emergency services agencies to revise and test the emergency response plan. The district updated its crisis response plan with input from Evergreen High School students and staff. In addition to the district crisis response plan, each school has its own Comprehensive Safe School Plan based on staff and student surveys. These plans are updated annually.

Evergreen High School maintains a safe and positive learning environment. Students are on the campus one day a week with varied schedules. Because of the limited amount of time each student spends at the site, there is not a lot of opportunity for interaction. The climate for learning is very positive. Students work one-on-one with their teacher and they receive a lot of encouragement and positive reinforcement. The students are very focused and self motivated.

#### School Safety Plan

The director of maintenance, operations and transportation is a member of the district management team and is in daily contact with the operations facilitator and the custodial supervisor to ensure an efficient cleaning process and schedule. The staff works together to ensure a clean and safe school.

**Deferred Maintenance Budget:**

The district participates in the State School Deferred Maintenance Program which provides state matching funds to assist school districts with expenditures for major repair or replacement of existing school building components. Deferred maintenance projects in the district include floor covering, heating and air conditioning, painting and paving.

## IX. Student Performance

### Standardized Testing and Reporting Program

The Standardized Testing and Reporting (STAR) Program consists of several key components, including the California Standards Tests (CSTs); the California Modified Assessment (CMA), and the California Alternate

Performance Assessment (CAPA). The CSTs show how well students are doing in relation to the state content standards. The CSTs include English-language arts (ELA) and mathematics in grades two through eleven; science in grades five, eight, and nine through eleven; and history-social science in grades eight, and ten through eleven. The CAPA includes ELA, mathematics, and science in grades two through eleven, and for science for grades five, eight, and ten. The CAPA is given to those students with significant cognitive disabilities whose disabilities prevent them from taking either the CSTs with accommodations or modifications or the CMA with accommodations. The CMA includes ELA and mathematics for grades three through eight and science in grade five and is an alternate assessment that is based on modified achievement standards. The CMA is designed to assess those students whose disabilities preclude them from achieving grade-level proficiency on an assessment of the California content standards with or without accommodations. Student scores are reported as performance levels.
